Per bid opening June 18, 2015, Floyd County Public Works respectfully recommends that we accept:

1. Bid of \$70,450 from Ag Pro for purchase of one John Deere tractor with Tiger mower with a 60 day delivery. Bid specifications were met.

Low bid of \$57,200 for a Kubota did not meet specifications in several areas, including tractor weight, mower lift assembly discrepancies and hydraulic tank size.

Second low bid of 63,490.68 did not meet specifications: tractor weight-Daniel advised he could add weights to meet the specs. Denton Wright had issues with that.
