Special Terms and Conditions

Terms:

- This service agreement will be for a period of one (1) year from the date of award. The Service Agreement provides for an additional two (2) one (1) year options provided both parties agree and the terms and conditions do not change.
- Either party wishing to terminate the agreement will submit a letter to the other party at least 30 days prior to the beginning of the next annual cycle (based on the award date).

Conditions:

- Each facility needs an inspection report with treatment details. The completed inspection reports will be required for monthly payment authorization by the Parks Superintendent.
- Monthly the awarded provider will notify the Parks Superintendent (3) days prior to treatment.
- Pest control will be conducted on first Monday and Tuesday of each month.
- Each Park must have a Parks Division Staff Member present to open doors.

SCOPE OF WORK

Standard Pest Control Services

All facilities are to be treated for ants, roaches, silverfish, mice, rats, fleas, wasps, spiders and any other pest observed to be present. Each month's treatment needs to be done on (2) consecutive days of continuous service, with the Shop Maintenance Building being the final stop. Pest Control Maintenance will be documented by facility in the inspection report and submitted with the invoice request for payment on a monthly basis.

Termite Services

All facilities noted as will need to be set up on a termite maintenance schedule. Termite Maintenance will be documented by facility in the inspection report and submitted with the invoice request for payment on a monthly basis.
