The following answers are provided for questions asked regarding this bid.

1. Please advise the size and gauge wanted for the Square Sign Posts? 1 3/4 X 1 3/4" X 10' and 12' or 2" X 2" X 10' or 12' and also 14 GA or 12 GA?

ANSWER: 2" X 2" X 10' – 12GA

2. You have requested pricing for transfer tape-paper. Do you want low tack, medium or high tack adhesive?

ANSWER: MEDIUM

3. On the 10' and 12' square post, is it 1 3/4", 2" or 2 1/4"?

ANSWER: 2"

4. On the 10' and 12' square post, do you want 14 gauge or 12 gauge?

ANSWER: 12GA

5. The 3' anchor will be 12 gauge, and will be 1/4" larger than the 10' and 12' post, please state if you want something different.

ANSWER: No, please comply with the specification as written

6. On the solar barricade lights, you have requested one that uses a 6 volt battery. The only solar assist light I can find uses D cell batteries. Can you give me a model number and manufacturer for the 6 volt battery solar light? Will you accept a solar light that uses D cell batteries instead of 6 volt? If yes, should I price the D cell batteries instead of the 6 volt lantern battery on the last line item?

ANSWER: This is a Standard 6 Volt Flasher that comes on when it gets dark (Has a Photocell)
