Notice is hereby given that Floyd County, Georgia proposes to let a Contract to the lowest responsive, responsible bidder, upon sealed bids, for the furnishing of all labor, material, equipment and other things necessary for the construction of the:

Sealed bids will be received until **2:00 PM** (local time), on **Friday, June 29th, 2018** at the office of the Floyd County Purchasing Director, located in the Floyd County Administration Building, 12 East Fourth Avenue, Suite 106, Rome, Georgia 30162. Sealed bids will then and there be publicly opened and read aloud in the office of the Purchasing Director. Late bids will not be accepted.

The purpose of this project is to construct improvements for the extension of Runway 1/19 by approximately 1260 feet to the north. In addition to the runway paving, the parallel taxiway will also need to be extended to provide access to the new runway end. The extended portion of the runway will be grooved, and the full-length of the runway will need pavement marking to be removed and new markings installed. The overall scope of work consists primarily of: clearing & grubbing, demolition and disposal of the existing localizer array and shelter, extensive erosion control measures, major grading and drainage improvements, bituminous pavement construction, construction of haul and access roads, airfield lighting and signage, and perimeter fencing.

PRE-BID CONFERENCE AND SITE VISIT will be held at **10:00 AM** (local time) on **Tuesday, June 12th, 2018** at the Airport Terminal conference room, 304 Russell Field Road, Rome, GA 30165. Site visit will follow.

Any contract executed pursuant to this notice shall be binding upon the Board of Commissioners of Floyd County, Georgia, as such, but will not create a liability expressed or implied, against any members of the Board of Commissioners of Floyd County, the Chairman of the Board, or employee of said County, in his or her individual capacity.
