Enclosed you will find the necessary information for preparing and submitting your bid for the **CHIPBuild 2018** project on behalf of the **South Rome Redevelopment Corporation, SRRC**. This bid is for construction of Four (4) houses.

Funding for the homes is a combination of Federal, State and local funds. The City of Rome is acting in a bid management and administrative/advisory capacity only. The South Rome Redevelopment Corporation is the sole developer of this project and will be responsible for review of all bids, project management, contractor payments, etc.

The deadline for submitting your bid is **November 28, 2018 at 3:00 p.m. local time. A pre-bid meeting will be held on site at 2 Pollock Street, Rome, GA 30161 on November 19, 2018 at 10 a.m.**

If your bid is over \$100,000 per home a bid bond in the amount of 5% of the highest amount bid for a single residence must accompany the bid submitted, and a 100% performance and payment bond will be required before any work can begin. (As each home will be contracted separately, these requirements are only applicable for any home that is bid over \$100,000).

Notice is hereby given that the City of Rome will receive sealed bids on behalf of the **South Rome Redevelopment Corporation** from interested parties until **November 28, 2018 at 3:00 p.m.** at its offices located at 601 Broad Street, Rome, Georgia 30162-1433.

Any bids received thereafter will not be considered.

Bids will be publicly opened and read at the City of Rome Purchasing Department located at 601 Broad Street on the day and at the hour specified.

The purchaser may consider as non-responsive, any bid in which there is an alteration of, or departure from the bid form hereto attached.

The bid will be awarded to the lowest reliable bidder complying with the conditions of the invitation for bid. The bidder to whom award is made will be notified at the earliest possible date. The purchaser reserves the right to reject the bid of a bidder who has previously failed to perform properly or complete on time, contracts of a similar nature, or the bid of a bidder who, in the sole opinion and discretion of the purchaser is not in a position to perform the contract, or whose name appears on the United States Comptroller General's list of ineligible contractors.

Bids may be withdrawn by written or faxed request, provided such withdrawals are received prior to bid opening date.

NOTE: Unless stated on the bid form the bid submitted will assume all specifications will be met. Please note on the bid form all exceptions.

Specifications CHIP 2018 Build Project

The **South Rome Redevelopment Corporation** (a local 501-C-3 non-profit) seeks qualified bidders to construct Four (4) homes in the South Rome Area. These homes are ranch style and includes 3 bedrooms, 2 bathrooms, living room, dining area, kitchen, laundry room, and a carport. The homes are estimated to have approximately 1138 sq. ft. of heated space.

The successful bidder will provide a bid price for each house individually and it must be turnkey pricing. There are a total of four (4) houses to be built. The houses will be constructed at 2 Pollock St, 4 Pollock St, 6 Pollock St, and 8 Pollock St.

Please Note: SRRC will be handling the grading of the site. Please do NOT include grading of the site in the contractor's bid pricing.

The contractor must provide all labor, tools, equipment and materials as described and shown on the drawings provided.

1. Each home must meet the State of Georgia "Visitability Requirements" of O.C.G.A 8-3-172. These include :
 - No step entry through a 36" in. door.
 - Each interior door is at least a standard 32 inch door, unless the door provides access only to a closet of less than 15 square feet in area.
 - Each hallway has a width of at least 36 inches and is level with ramped or bevel changes at each door threshold.
 - Each bathroom wall is reinforced for potential installation of grab bars.
 - Each electrical panel or breaker box (located on the first floor), light switch or thermostat is not higher than 48 inches above the floor.
 - Each electric plus or other receptacle is at least 15 inches above the floor

3. The homes will be constructed on a concrete slab, a slab/partial crawl or crawl space depending on the topography of each individual lot. A no step entrance must be provided at each home. The South Rome Redevelopment Corporation will do all preliminary site work and grading on the lots in preparation for construction.
