Floyd County is requesting bids for surplus weapons confiscated by the Rome/Floyd Metro Drug Task Force. All bids will be submitted on the attached Bid sheet. Weapons will be sold in 2 lots; Hand Guns and Long Guns as indicated in the following pages. By submission of an offer, you are agreeing to purchase one or both lots in their entirety.

**Floyd County will award each lot to highest bidder.** Payment accepted will be cash, money order or cashier's check. Payment will be made to "Rome/Floyd Metro Drug Task Force".

Payment is due following notification of award. All sales are final and express no warranty written or otherwise. Pickup will be made within 15 business days only after a full payment is made for the weapons.

**Bidders will be licensed as firearms collectors, dealers, importers, or manufacturers** under the provisions of 18 U.S.C. Section 921, et seq., and Chapter 16 of Title 43 and who are authorized to receive such firearms under the terms of such license. **Bidders will provide a copy of their license with the bid.** The buyer(s) will be responsible for the transfer of weapons and all necessary documentation. Buyers will be responsible for all packaging, boxing, crating and transportation.
