FLOYD COUNTY

- The Recycling Center will hold several community events throughout the year
- The Recycling Center will perform all labor to consolidate and categorize the E-WASTE collected.
- The Recycling Center then notify the selected E-Waste contractor after an event to pick up materials once it is sorted and consolidated.
- The Recycling Center will assist in loading the contractors truck however will not be responsible for the load while in transit.
- The Recycling Center does not send refrigerated units, microwave ovens, vacuum cleaners, liquids, Identified Hazardous materials, etc..
- Peripherals to include Printers, Printer and toner Cartridges, Scanners, Mice, Keyboards, Speakers, Cables and any other items commonly associated with Computers.
- E-Waste pick up will be at Rome Floyd County Recycle Center located at 412 Lavender Dive Rome Ga. 30165
