Answer: M-F, 8am-5pm.
5. Question: Is your office open Monday - Friday?  
Answer: Yes.
6. Question When is the award date?  
Answer: As posted in the bid package on our website.
7. Question: When is the first board meeting after the opening?  
Answer: September 8,2020
8. Question: Will decision be made before or at the board meeting?  
Answer: A decision will be made and presented to the board for approval. That date is not yet certain.
9. Question: Will you accept up to 5% bio diesel in your diesel fuel?  
Answer: No

11. Question: Can or will deliveries be split between locations and products?  
Answers: Deliveries to each site should be full loads.
12. Question: Can I get a copy of 3 recent invoices and BOL's from the last 6 months of each gasoline and diesel?  
Answer: Already posted on our website, [www.romefloyd.com](http://www.romefloyd.com).
13. Question: Can we please have a list of bidders invited to submit a proposal?  
Answer: There is no list available. It is an open solicitation.
14. Question: Will the ability to accept credit card payments be a vital part of the award decision?  
Answer. It could carry some weight. We primarily wanted to know if that payment option was available.
15. Question: Your bid states "The total price to be quoted in any proposal submitted shall include all delivery charges and any taxes that are applicable." , but you have a separate line on your pricing page for taxes. Can you please clarify if taxes should be IN price or Listed Separately?  
Answer: Mark up, overhead, profit, etc. should be an amount on a single line. Any taxes that are required to be paid should be shown on the tax line. There should not be a fuel cost shown at all since the price would be for a specific day. Taxes should be shown but not included in the fuel cost provided.
16. Question: Is there a tie-to date for the bid pricing to ensure all vendors are using rack prices from the same date? Side Note: This is something PTC would like to recommend as it is easier to compare when awarding as it could change anywhere from .01 to .20 depending on the day/market.  
Answer: A rack rate price should not be provided at this time.
